Appointment to Beamtree Board – Mrs Emma Gray

Beamtree Holdings Limited (“**Beamtree**” or “**the Company**”) (ASX: BMT), a leading provider of AI decision support and data insights solutions, is pleased to announce the agreement to appoint Mrs Emma Gray as a non-executive director with effect from our Annual General Meeting (“AGM”) on the 24th of November 2022.

Mrs Gray will stand for election at ASX’s Annual General Meeting on 24th November 2022. Beamtree Chairman, Mike Hill said: “The Board and I are delighted that Emma has agreed to join us. She brings to the Board over 10 years’ experience in data analytics and automation and a strong understanding of BMT and its businesses.”

Emma has served for the past two years as the Group Executive, Data and Automation with ANZ Banking Group. Prior to becoming a Member of ANZs Group Executive, Emma was the Chief Data Officer at ANZ from February 2017 to April 2020.

Within ANZ, Emma was responsible for driving data and automation agenda across ANZ Group, one of Australia’s largest banks. Across Data, responsibilities included the build, deployment and governance of data infrastructure, assets and capability, with a focus on driving commercial use of data internally and commercializing those capabilities externally.

Prior to ANZ, Emma was Chief Loyalty and Data Officer at Woolworths Limited for four years and earlier in her career was a partner for fifteen years with Bain and Company in Sydney, London and San Francisco.

Emma clearly brings very strong business acumen and significant data insights to the skillset already within the Beamtree board. Emma will join the board as an Observer immediately and formally will join at the AGM of the Company.

In accordance with Rotation and re-election policy of the Company, Paul Williams and Andrew Gray will retire from the Beamtree board on the same date at the AGM. Both Paul and Andrew have significantly contributed to the Beamtree board from the date of the IPO. The board thanks them for their contributions to date. Both Paul and Andrew will remain as Directors up until their resignation on the 24th November 2022.
